

EVENT WAIVER

Please read the waiver below carefully before accepting or signing acknowledgement and release from liability and potential claims based upon negligence and/or reckless misconduct, before continuing with this entry.

DEFINITIONS

In this Agreement, the term “Organisers” shall include Crankworx Events Incorporated, ITS GmbH and its contractors, designee, commissaries, authorities or other parties associated with the event. “Mountain biking” shall include all activities, events, services or use of facilities provided, arranged organized or conducted by the Organisers including but not limited to: cycling; bike descents; mountain bike tours; use of the Bikepark Innsbruck (Muttereralmbahn, Nockspitzbahn, Muttereralmpark); bicycle skills training; use of trails and roads across all Innsbruck event sites; guided mountain biking activities; races; competitions; demonstrations and events; orientation and instructional courses and sessions; slopestyle, whip-off, dual slalom (AM and PRO), speed and style, downhill, pump track (incl pumptrack next) BMX courses and races, and all other related activities, events or services. “Special Events” shall refer to any and all related activities organized, conducted or sponsored by the Organisers, including, but not limited to, races, competitions, demonstrations, training and other such events or activities associated with Crankworx Innsbruck, scheduled for 30th of September – 4th of October 2020.

ASSUMPTION OF RISKS

Injuries are a common and expected part of mountain biking. Mountain biking across all Crankworx Innsbruck official event sites and the adjoining properties takes place on steep and rugged terrain and includes features that are both physically and technically challenging and will expose the rider to many risks, dangers and hazards. These include but are not limited to: use of gondolas; changing weather conditions; mechanical failure of equipment; falls; loss of balance; high speed descents; difficulty or inability to control one’s speed and direction; rapid or uncontrolled acceleration on hills and inclines; extreme variation in cycling terrain including steep or slippery sections, trees, roots, tree stumps, logs, cliffs, rocks, rock drops, loose gravel, holes, depressions, streams and creeks; constructed feature such as bridges, ramps, ladders, bumps, berms, jumps, and drops; collisions with natural and constructed objects, other mountain bikers, vehicles, pedestrians, spectators and officials; negligence of other riders or users of the premises.

SAFETY

I have been advised to wear an approved helmet and other protective equipment such as elbow/forearm and knee/shin armour when riding. In case I participate in the Crankworx Innsbruck Downhill I understand and confirm that I will wear the MANDATORY equipment for riders, according to the rules of the Austrian Cycling Federation, which is:

- a full-face helmet
- knee-, elbow- and back protection
- gloves with full hand protection
- shirt with at least short sleeves

IMAGE RELEASE

As a condition of my participation in all events, I hereby unconditionally and irrevocably consent, authorize and grant Crankworx Events Inc. (“CEI”), the event organizers of each event, and their respective affiliates, sponsors, promoters, advertisers, broadcasters, webcasters, contractors, agents, representatives, licensees and assigns (together, the “Releasees” all the necessary authority, right and license and permission to use photographs, audio or video recordings, or other forms of recordings that capture my image, likeness, voice or performance (or all of these) (collectively hereinafter referred to as “Images”), in which I may be included in whole or in part, in any manner or media, including print, broadcast, internet media, direct marketing channels, downloadable content and applications, and all other technologies now known or hereafter developed. I acknowledge that drones may be used in capturing these images and accept that they may be flying above me. The Images may be used or exploited for any commercial or non-commercial purpose whatsoever, and may be altered, modified, changed, combined or incorporated into other works. I hereby relinquish any rights I may have in the Images (including privacy, personality and publicity rights). No fees or other compensation whatsoever will be provided to me for or in connection with the use of the Images. I hereby release the Releasees from any and all claims which I may now or in the future have relating to the ownership, reproductions, display, distribution or other use of the Images. The signatory agrees to photographic images of him/her being used free of charge for the purposes set out above. Photographic images shall not be used for any other purposes than those described. Signatories provide consent of their own free will. No disadvantages will result if consent is withheld. Consent can be provided at any time with immediate effect.

AGREEMENT

1. I certify I am physically fit, have trained sufficiently for participation in this event and have not been advised otherwise by a qualified medical professional or trainer. In my judgment I have sufficient competence, experience and skill to complete the event using the equipment I chose to compete with on the day of the event. I do not believe that my health or safety, or that of fellow participants, officials, spectators, sponsors, contractors, land and property owners or members of the public attending the event will be put at risk by my participation in this event.
2. I understand that the events taking place involve mountain biking. I am aware it carries a degree of risk and can be a potentially dangerous activity capable of serious injury or death as a result of participation. I agree that my participation in this event is entirely and knowingly at my own personal risk and I am solely responsible for my own safety and property, including the cost of any services required in recovery of myself or my property as a result of an incident. I am aware the hazards include, but are not limited to, the condition of my equipment, actions or inactions of myself, other competitors, spectators, sponsors, the organiser and officials, contractors, land and property owners, members of the public, the weather conditions, air temperature, and all natural or man-made features encountered on the course.
3. I acknowledge that safety precautions undertaken by organisers (such as, but not limited to, competitor race pack notes, the event briefing, course marking, marshals, officials, contractors in place etc.) are a service to me and other competitors but are not a guarantee of safety.
4. I accept that I have an important responsibility to carefully read and listen to all safety information provided and to immediately seek clarification on anything which is not entirely clear to me.
5. I hereby give consent to receive medical treatment which may be deemed necessary in the event of injury, accident and/or illness during the event.
6. The organiser reserves the right to delay the event; alter the advertised course or start time of the event due to circumstances beyond the control of the event directors. If this occurs, I consent to the changes and I agree that each and every one of the conditions herein set out shall apply to that changed event.
7. I have read the information concerning withdrawal, cancellation of the event, and refunds of entry fees and agree to all conditions set forth in the event information. If the event is cancelled due to extreme weather, natural disaster or any other condition beyond the control of the organiser, I understand that my entry/ registration fee will not be refunded.
8. I agree to abide by all Anti-Doping testing protocol & procedures undertaken by NADA (*Nationale Anti-Doping Agentur Austria GmbH*) or any other official Anti-Doping Agency.
9. I hereby take action for myself, support crew, my executers, administrators, heirs, next of kin, successors, signatories and assigns as follows:
 - a. Waive, release and discharge from any and all liability for death, disability, personal injury, property damage, property theft, property loss, and all other foreseeable risk or claims or actions of any kind (including negligence and/or recklessness) whatever and however occurring which I at any time had or have as a result of or in connection with, directly or indirectly, my participation in and my traveling to and from this event the following person(s) or entitles : the Event organisers; land and property managers and/or owners, race directors; event sponsors; event volunteers; district council; or other areas of whatever nature in which the event may be staged, its representatives, respective officers, directors, employees, independent contractors, agents, and volunteers.
 - b. Indemnify and hold harmless the persons or entities mentioned in paragraph 9 (a) above from any and all liabilities, claims or actions (including negligence and/or recklessness) whatever or however caused, arising as a result of or in connection with, directly or indirectly, my participation in and traveling to and from this event.
10. I agree to my name and contact details being included on the event database. These maybe used for promotional purposes by event stakeholders. I may unsubscribe from this at any time.
11. I understand that the official event registration, briefing, start and finish, event, plus prize giving will be held at both private venues and public sites and I must respect land/property owner's and the public's rights.
12. I hereby understand that in any case of loss of my lift tickets for the use of all lift facilities of Bikepark Innsbruck (Muttereralmbahn, Nockspitzbahn, Muttereralmpark), provided by the event organizers, there will be no reimbursement or compensation in any way. If the usage of the lift service is required for any of my participations in any event or activity of Crankworx Innsbruck, I have to purchase new tickets at my own costs.
13. I understand that I have to wear the athlete's wristband, provided at the accreditation, at any time of the event, to get access to the field of play.

14. This document shall be construed in accordance with the Laws of Austria and any dispute, difference or question of any kind which may arise between any of the parties shall be determined in accordance with the Laws of Austria.
15. I hereby declare that all information given on the entry form is true and correct.
16. I hereby certify that I am 18 years of age or older. If I am under the age of 18 years I will have these waiver terms and conditions viewed and signed to by my legal guardian which will in effect give consent for me to participate in the event.
